

SUNSHINE COAST AIRPORT 'SPIN AND WIN' HOLIDAY PROMOTION TERMS AND CONDITIONS

- 1. This competition ("Competition") is conducted by Sunshine Coast Airport Pty Ltd ATF Sunshine Coast Airport Trust (SCAPL) of ABN 80-884-271-876 of 10 Electra Lane, Marcoola QLD 4564 4218, phone 1300 993 543, ("Promoter").
- 2. Entry to the Competition constitutes acceptance of these terms and conditions. All entry instructions and prize information published by the Promoter form part of these terms and conditions.
- 3. The Competition is only open to individuals who:
- (i) are Australian permanent residents aged 18 years or over.

- (iii) who are not employees of the Promoter or any of its related corporations or any of their agencies associated with the Competition; ("Entrant").

THE PRIZE AND THE WINNER

- 16. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.
- 17. The Prize Winner will be notified in writing via email within two days of the draw and will have 72 hours from date of email notification to claim prize. The Prize notification will state that the Prize has been won and will include instructions as to how the Winner may claim the Prize and establish his/her entitlement to it.
